



WAIVER, INDEMNITY & RELEASE OF LIABILITY
(the "WIR")

for Youth Field Trip to the Dinos Centre
Thursday, April 11, 2019

I, _____ (the "Participant"), or the parent/guardian of the Participant, if the child is under the age of 18, understand, acknowledge and accept that:

1. The Alberta Home Education Association ("AHEA") is a volunteer organization dedicated to supporting home educating parents, to creating a forum for interaction between home educating families, and to facilitating constructive dialogue between governing education authorities and home educating parents.
2. AHEA has planned a convention, April 11-13, 2019, intended to advance AHEA's purposes (the "Convention");
3. Concurrent with the Convention, AHEA's Youth Coordinator has arranged for a trip to the Dinos Centre, and return transportation between the Convention and Dinos Centre for attendees between the ages of 12 - 25 (collectively, the "Outing");
4. AHEA volunteers have planned and will join the Outing;
5. The Outing includes travel by bus or other motorized vehicle from the Convention location to The Dinos Centre and back;
6. The Outing includes pedestrian travel in, around and about Dinos Centre;
7. The Outing is a group activity, involving others for whom AHEA and its members, Board, agents, contractors, volunteers and Outing planners bear no responsibility;
8. The Participant is not entitled to go on the Outing merely by virtue of attending the Convention or of paying to attend the Convention or of the Participant's parent or guardian paying to attend the Convention; and
9. The Participant is under no pressure, obligation or compulsion to participate in the Outing, rather the Participant is able to join and benefit from the Outing in consideration of promising to perform the terms and covenants in this WIR.

In the event of any dispute or disagreement arising from the Outing involving the Participant, the Participant and any representative, counsel or agent for the Participant shall at all times proceed and attempt to resolve such concerns in accordance with Biblical principles including, but not limited to, those in Matthew 18:15-17 and I Corinthians 6:1-11.

I hereby authorize AHEA's Outing organizer(s), if at any time circumstances warrant, in AHEA's or in AHEA's Outing organizer(s)' sole opinion and absolute discretion, to exhort, reprimand or exclude from the remainder of the Outing the Participant, understanding and agreeing that I shall bear all costs and consequences of such removal, return transportation and damages of whatsoever kind suffered by anyone, including other Participants, and including any company, organization or property owner (collectively, "All Damages"), without protestation or contestation, regardless of how those costs or damages arose or were contributed to by others.

I further hereby forever release All Damages, including AHEA, from all causes of action I may have now or in the future against them in any way related to the Outing, and I further waive all defences I may have now or in the future to causes of action against me in any way related to the Outing.

I further indemnify and hold harmless AHEA, its members, Board, volunteers, agents, contractors and Outing planners and organizer(s) from all damages, including actions brought against them or any one of them by any others, resulting from the acts or omissions of the Participant or from acts or omissions the Participant contributed to in any way, arising during, in connection with, or in any way related to, the Outing.

I have had sufficient opportunity to read this WIR. I have had sufficient opportunity to ask any questions I may have about the Outing, its risks, and the legal effect of this WIR.
